Q. Why aren't the sound effects working?

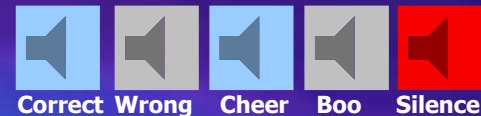
