## A RESOLUTION-QUERY INTERSTATE CASES FOR KIDS (QUICK)

WHEREAS, the Eastern Regional Interstate Child Support Association (ERICSA) was established in 1963 to promote the development of effective family and child support programs;

WHEREAS, ERICSA brings together judges and other decision-makers, public and private attorneys, and child support professionals traditionally from 33 states and territories bordering on, and east of, the Mississippi River as well as the District of Columbia;

WHEREAS, the Query Interstate Cases for Kids (QUICK) project implemented by the Federal Office of Child Support Enforcement provides states with a secure interface to access and view information in other states;


WHEREAS, QUICK facilitates communications through use of standard data definitions and improves the consistency of these definitions;

WHEREAS, QUICK presents information in a format with similar "look and feel", provides caseworkers with an electronic tool that allows them to view information in "real-time", improves interstate communications between states and improves customer service response time;

WHEREAS, participating states have affirmed the value of QUICK and endorses its use,

WHEREAS, the QUICK system rather than the worker responds to questions;

NOW, THEREFORE, BE IT RESOLVED, this 10th day of May, 2007, at its 44th Annual Training Conference held in Norfolk, Virginia, that the Eastern Regional Interstate Child Support Association, its President, and its Board of Directors, acknowledge the benefits of states using the Query Interstate Cases for Kids (QUICK) project and encourage all states to update their case identifiers using the Interstate Case Reconciliation project, so as to maximize the potential for QUICK. We further support universal implementation of QUICK in all states with training and support to facilitate use by staff processing cases at the state and local level.
