What is Paternity Establishment?

- "To legally add the father's name to a birth certificate if the mother is unmarried."
- Generally, paternity can be established in three ways
 - -AOP
 - Administratively
 - Court Determined



Federally Mandated?



State Mandated?

SC

 Law specifies that "DHEC and the State DSS, in conjunction with the South Carolina Hospital Association, shall develop and implement a program to promote obtaining voluntary acknowledgments of paternity as soon after birth as possible and where possible before the release of the newborn from the hospital..."

- The Child Support Enforcement
Division of DSS created the SC
Parenting Opportunity Program to
administer its responsibilities in the
process.



National Establishment Data



- 2007 brings a record
 4.31M babies
 - 40% or 1.7M of all births were to unmarried adult women
 - 10% increase of births to25-29 year olds
 - 20% increase since 2002
 - Teen mothers 23%

SC Specifics

Births to unmarried parents in South Carolina

27,226 in 2006

28,351 in 2007

29,225 in 2008; 49% of all SC births



VA Specifics



- Births to unmarried parents in Virginia
 - -36,269 in 2006
 - -38,189 in 2007
 - -37,944 in 2008;
 - Represents 35% of all births in VA
 - 24,086 babies went home with dads on their birth certificate

Working Together for Children and Families – A "Shore" Thing

South Carolina's Rates of Interest

Virginia's Rates of Interest

- 2008 VA Hospital Preliminary Establishment Rate 64%
- 62 VA Birthing Hospitals
 - Total births 108,417
 - Understaffed
 - Limited coverage
 - Budget constraints
 - Employee turnover





Program Progression-SC

- SCPOP was outsourced to PSI in March 2007
- Established baseline in-hospital PEP of 33% (44% total PEP) for the 2006 calendar year.
- The goal set for the program was to get the in-hospital PEP up to 60%.



Program Progression-SC

- We have seen a 10% increase in the inhospital PEP (11% increase in total PEP) in two years.
- Helped DSS avoid corrective action from Federal Government in FFY 2008 and facilitated a switch from IV-D PEP reporting to Statewide PEP reporting



Program Progression-VA



- -Originally outsourced in 2003
 - In hospital PEP rate in 2003 was 48%
- -Preliminary numbers for 2008 indicate a 64% hospital establishment rate



Program Progression-VA



- -Program goals are to increase rates by 2-3% yearly; ultimately reaching 80%
- -DCSE has been able to receive 100% of Federal Incentive Monies each **FFY**



Discussing Paternity



- At the time of birth, is the best time to talk about paternity establishment (Fragile Family Study)
 - The greatest statistical indicator of whether or not an unmarried dad will be involved in his child's life IS WHETHER OR NOT HE ESTABLISHED LEGAL PATERNITY!



Standard Outreach Activities

- Site Visits
- Regional annual training/conferences
- Educational materials
- Guides to assist hospitals with **Paternity Acknowledgments**
- Newsletters
- Monthly statistical monitoring to track performance



Barriers

- Location of staff within the hospital; **OB vs. Medical Records**
- Unwillingness of staff to adequately explain rights and responsibilities
- Dealing effectively with illegal immigrants and language barriers
- Overall ineffectiveness of the Paternity Acknowledgment



Barriers

- Fathers not showing up to the hospital
- Fathers not having proper ID
- Lack of authority of staff
- Staff unavailable on nights and weekends; when dads visit
- Staff are not notaries; can not complete documents

Best Practice Ideas-SC

- Distribute SCPOP materials to other hospital components that work with expecting mothers.
- Show the SCPOP Parent Video.
- Increase the number of notaries.
- Paternity Challenge.
- DNA testing options.
- If Birth Clerks work in Medical Records:

 Ask for access to a computer in the PostPartum area with EBC loaded on it.


